\_\_\_\_\_ School is committed to providing a technology rich environment for our students. The use of Information and Communication Technology (ICT) is fundamental in assisting teaching and learning in all areas of the school curriculum.

The *myfuture* online platform is Australia's National Career Information Service, managed by Education Services Australia. It provides career guidance information and activities and is used by teachers and students across primary schools, high schools, and colleges.

There are currently over 4,000 public school students registered to use *myfuture* in the ACT. The Education Directorate has introduced access to *myfuture* for students via single sign-on in the Digital Backpack. This will allow students to access the *myfuture* platform using their school details without the need to create a new login or account credentials, saving both teachers and students valuable classroom time.

*myfuture* is a third-party web-based service that requires some basic personal information for students to access various information and activities within the online platform. Parent/guardian permission is required to enable your child's access to *myfuture*.

To assist you in deciding whether to give consent, additional information about *myfuture* is provided overleaf including the website address and a link to the provider's privacy policy and terms and conditions of use.

You are not required to consent – this is a matter entirely at your discretion. If you do not consent, your child will not use this website as part of their classroom learning.
